- **ALL music – CDs ONLY - for Bodybuilders and Fitness will be collected at the Check-In/Weigh-In.**

**SATURDAY, MAY 1 – PREJUDGING - ALL COMPETITORS**

- **8:00 AM** - Meeting for NPC Bodybuilders and IFBB Figure/Fitness.
- **9:00 AM** - Prejudging begins.

**SATURDAY, MAY 1 – FINALS – ALL DIVISIONS**

- **5:30 PM** - Meeting for all NPC competitors.
- **6:00 PM** - Finals begins.

**COMPETITION DIVISIONS:**

- **Open Men** – 7 Classes, 5 places and 1 Overall. (Up to 143 ¼, over 143 ¼ to 154 ¼, over 154 ¼ to 165 ¼, over 165 ¼ to 176 ¼, over 176 ¼ to 198 ¼, over 198 ¼ to 225 ¼, over 225 ¼)
- **Teen Men/Over 35 Men/Over 40 Men/Over 50 Men/Over 60 Men** – Each Division has 1 Class, 5 places
- **Novice Men** – 2 Weight Classes, 5 places and 1 Overall. (Up to and including 176 ¼, over 176 ¼)
- **Closed Mr. Pittsburgh** – For competitors from Western PA only. 4 Wt Classes, 5 places and 1 Overall.
  - (Up to 154 ¼, above 154 ¼ to 176 ¼, above 176 ¼ to 198 ¼, over 198 ¼)
- **Women Bodybuilding** – 3 Classes, 5 places and 1 Overall. (Up to 125, over 125 up to 140, over 140)
- **Figure** – 4 classes, 5 places and 1 Overall (Up to 5'2", over 5'2" up to 5'4", over 5'4" up to 5'6", over 5'6")
- **Over 35 Figure** – 2 classes, 5 places and 1 overall (Up to 5'4", over 5'4")
- **Fitness** – 1 Class, 5 places
- **Bikini** – 3 classes, 5 places and 1 overall (Up to 5'4", over 5'4" up to 5'6", over 5'6")

**NATIONAL QUALIFIER** – The following placings qualify for NPC National Level events through 2011.

- Bodybuilding: Open Men – Top 2 in each class    Women BB – Top 3 in each class.
- Fitness – Top 5 in each class.
- Figure – Top 3 qualify for any national event.
- Figure - Top 5 qualify for Jr USA, North America, Team Universe and Masters Nationals.
- Bikini – Top 5 qualify for any national event.

**MUSIC** - Contestants must supply their own music – no more than 60 seconds – **CDs ONLY**.

- Posing music **MUST BE THE ONLY** music on the CD. No vulgar music is permitted!
- **ALL music will be collected at the Friday Check-in/Weigh-in!**

**PREJUDGING POSING** - All Bodybuilding competitors will perform a 60-second routine at the Prejudging.

- Fitness competitors will perform their routines at the Finals only.

**FINALS – BODYBUILDERS** - ALL bodybuilders will perform their 60-second routine at the finals.
