**BB Teen Men/Over 35 Men/Over 40 Men/Over 50 Men/Over 60 Men** – Each Division has 1 Class, 5 places

**BB Novice Men** – 2 Weight Classes, 5 places and 1 Overall. (Up to and including 176 ¼, over 176 ¼)

**BB Closed Mr. Pittsburgh – For competitors from Western Pennsylvania only.**

**Bikini Over 35** – 2 classes, 5 places and 1 overall (Up to 5'4", over 5'4")

**Bikini Novice** – 2 classes, 5 places and 1 overall (Up to 5'4", over 5'4")

**Bikini Teen** – 1 class, 5 places

## **BODYBUILDING, WOMEN'S PHYSIQUE AND CLASSIC PHYSIQUE INDIVIDUAL ROUTINES**

**PREJUDGING** – There will NOT be any Posing Routines at the Prejudging.

**FINALS** – ALL BB/Women's Physique/Classic Physique competitors will perform their Routines at the Finals.

**MUSIC** – BB/Women's Physique/Classic Physique music will be collected at Friday Check-ins – 70 seconds max.

**NATIONAL QUALIFIER** – The following placings become Nationally Qualified through all of 2018:

**Top 3 in OPEN CLASS** - qualify for ANY national event.

**Top 5 in OPEN CLASS** - qualify for Jr USA, Jr Nationals, Team Universe, North America.

**NOVICE DIVISION** – Competitors who never won an Overall title.

**ENTRY FEE** – A fee of \$100.00 will be charged for each Division. The entry fee must be sent with your application.
